### Notes from Steve ...



On July 19, 2009 Farrington's Grove's board had its annual retreat. The event was well attended

and a number of important topics were discussed. In addition, the members present were provided with updates about projects in the neighborhood:

New street signs. As you travel throughout the area you will see that the new street signs have been put up thanks to the work of Brad Miller and his crew from the city street department. Everyone in the neighborhood is very thankful for their work in completing this important project. A number of people have indicated that they now have a better understanding of the boundaries of this National Register Historic District. Several people have also mentioned that at the gateways to the neighborhood we might want to consider having larger street signs that more clearly display the logo and wording that appears on each of the street signs. I plan to bring this up at our meeting in September for discussion.

Street trees on S. 4th. At long last the trees on 4th street have been replaced and appear to be doing well. Marie and I often ride our bikes on the 4th street bike trail and have noted the progress. To date the bike route does not have any lettering indicating that it is a bike trail and I intend to bring this to the attention of the city. You may not be aware, but the parks department also has a crew that travels the route and makes sure that it is clean and the trees get watered. I am sure this is much appreciated by the residents on the west side of 4th street.

Yellow no-parking paint on curbs. Last year a number of the residents in the neighborhood completed an inventory of the curbs that needed to be painted to prevent cars from parking too close to intersections. At the retreat this subject was brought up and Todd Nation indicated that he would make contact with the street department to ask if further work could be done to complete the project on the whole neighborhood. He did, and on Wednesday July 29th the street department was working on 4th street, painting curbs that did not get completed last fall. Hopefully they will expand their work to include the rest of the neighborhood. If you see crews on your street, please thank them for their hard work.

Annual Block Party. The 3rd Annual Block Party is scheduled for Sunday, August 30th from 1-4 p.m. on the grounds of the Vigo County History Museum at the corner of 6th and Washington. Geoff Wayton had been working to have a 5K race through the neighborhood as part of the fun this summer. Unfortunately we were not able to get approval to temporarily close several streets for runners to cross, so we will try again next year. We all appreciate the work that Geoff did in trying to make this happen. I think it is great way to introduce people to the neighborhood. Christine Hamilton and Colleen Chestnut are co-chairs of the block party this summer and have great activities planned. Please come and share in an afternoon of fun.

Security & Crime Task Force. ISU Criminal Justice Professor (and 'Grove neighbor) DeVere Woods and his students from ISU spent most of the spring semester analyzing crime data that was provided by the city police department. Their draft report was distributed and discussed at the board retreat. The next step in this process is to map the location of each police report so we can identify hotspots in the neighborhood and then develop strategies to reduce these problems by carefully coordinating our efforts with the police department. We also understand from Mayor Bennett that the city is looking into getting software that will enable citizens to gain better access to crime statistics. In the meantime, the website, http://baware.us provides crime reports by quadrant of Terre Haute. The southwest district includes Farrington's Grove. Unfortunately, this site's data, like our data, is not mapped. However, there is detailed information at the site on the location of sex offenders in the district including maps, information about the individual and their photograph.

FGHD Zoning. At the last meeting of FGHD we discussed the benefit of distributing a map of the neighborhood showing how each property is zoned (residential, commercial, etc) and information about uses that are permitted in each zoning classification. For example, if you live in an R2 district, (residential 2family) you can see what activities are allowed. We're hoping to get a summary of this information along with a zoning map of the neighborhood posted on our web site shortly.

Membership stickers. There was also discussion about the possibility of printing stickers that could be placed in the window or on bumpers of FGHD

### HISTORICAL SOCIETY HAPPENINGS

The new exhibit at the Vigo County Historical Museum is designed to make every woman feel that doing laundry today is a "breeze." Called "Monday Was Washday", the display features some of the earliest "washing machines." These contraptions and accessories were considered, in their day, to make wash easy for the woman of the house.

The earliest washing "machine" was the scrub board which was invented in 1797. Before that, clothing was cleaned by rubbing them on rocks in local streams. It wasn't until 1858 that a rotary washing machine was invented by Hamilton Smith. Just as the scrub board required "elbow grease" of the user, the rotary machine or one that

moved the clothes from side to side was powered by the person using it.

By the early 1900s, wooden wash tubs were replaced by metal tubs. In 1907, the Maytag Corporation began manufacturing wooden tub washing machines with a flywheel. In 1908, the first washing machine was invented by Alva J. Fisher. Finally, in the 1930s the Bendix Corporation produced a machine that could wash, rinse, and extract water from clothes in a single operation. After WW II, technology took off and the house wife was relieved of many wash day burdens.

Visit the Historical Museum to see many of the early methods of doing "the wash." After viewing the current exhibit, it's easy to see how the term "Wash Day Blues" came about.

A special Historical Society event is coming on October 17th and we hope residents of the Farrington's Grove neighborhood will plan to attend. Like our Gatsby Days Party at the Hulman Lodge in May, a 1930s theme will be carried out. The



evening will be a celebration of the end of that era of history. To be held at the Ohio Building and with a different style of live music on each floor, the finale of the evening will be a reverse raffle of a Model A Ford automobile which has been purchased for this event.
